WITHDRAWAL RIGHTS

1. The Buyer has the right to withdraw from the contract for the purchase of the Product within 14 (fourteen) days without giving any reason for the withdrawal.
2. The period for exercising the right of withdrawal expires after 14 (fourteen) days from the date of receipt of the Product.
3. During the period for exercising the right of withdrawal, the consumer has the right to use the product to the extent necessary to inspect it (to the same extent as would have been possible before the product was purchased in a physical store).
4. When exercising the right of withdrawal, the consumer shall be liable for any use of the product which goes beyond the purpose of examination, for any use of the product during the period of exercise of the right of withdrawal which is incompatible with the principle of good faith and for any reduction in the value, quality and safety of the product.
5. **The Buyer may not exercise the right of withdrawal if the Product has been manufactured according to the Buyer's instructions or measurements.**
6. In order to exercise the right of withdrawal, the Buyer must inform the Seller of its decision to withdraw from this Contract by express notice. The Buyer may use the attached sample withdrawal form but it is not compulsory to do so.
7. For the right of withdrawal to be respected, it is sufficient if the Buyer sends the notice of exercise of the right of withdrawal before the expiry of the right of withdrawal.

WITHDRAWAL CONSEQUENCES

1. If the Buyer withdraws from this Contract, the Seller will refund the Buyer the amount paid without undue delay and in any event no later than 14 (fourteen) days from the date on which the Seller was informed of the Buyer's decision to withdraw from this Contract.
2. Refunds shall be made using the same means of payment as used by the Buyer when entering into the contract for the purchase of the Product.
3. The Seller may withhold the repayment until the Product has been returned or the Buyer has provided proof that the Product has been returned (whichever occurs first).
4. The Buyer must return or hand over the Product to the Seller without unreasonable delay and in any event no later than 14 (fourteen) days from the date on which the Buyer gives notice of its decision to withdraw from this Contract. The time limit is complied with if the Buyer returns the Product before the expiry of the 14 (fourteen) day period.
5. The Buyer is liable for any direct costs of returning the Product.
6. The Buyer is liable for any reduction in value of the Product if the Product has been used for purposes other than determining the nature, characteristics or performance of the Product. The Product can be used for inspecting it to the same extent as would have been possible before the product was purchased in a physical store.
